The Illinois Department of Public Health (IDPH) staff was on hand to give a short update on how the levels of care committees are going.

- Q: How many hospitals in the state are/are not accredited from JCAHO? A: 210 Hospitals, 24 are not accredited by JCAHO, 20 of those 24 are critical access. 4 of the 24 are acute care.
- Question: Are there any maternity service hospitals that are not accredited? A: IDPH will look into it.

2. Change of Network / Designation Process Discussion

- Jenny Brandenburg was on hand to go over the discussion from earlier in the day over the Certificate of Need.
- The board takes geographic need of beds into consideration when looking at a certificate of need, however they do not look at it for the certificate of exemption.
- Went over the difference in Certificate of Need and Certificate of Exemption.
- Elaine asked Jenny to talk about what her Designation, Redesignation, and Change of Network group has been working on:
 - They have looked at the Designation process and how it will have much different requirements than the Redesignation process.
 - They also talked about having an annual site visit materials review so that way when their redesignation came up it would be more of a streamlined process.
 - Want to look at having a real time dashboard type where hospitals and facilities could enter data. Also looking at streamlining or simplifying the data.
