I have not been doing them for any resident." V8 verified R39, R118, R120, R121, R122, R123, R124, and R125's background checks do not include the Illinois Department of Corrections Sex Registrant website check. The facility's CMS (Centers for Medicare and Medicaid Services) Long Term Care Facility Application for Medicare and Medicaid Form 671 dated 9/22/25 and signed by V1/Administrator documents 110 residents currently reside within the facility.
